3. Data We Collect

We collect and process the following types of personal data:

4. Purpose of Data Processing

Your personal data is collected and processed for the following purposes:

5. Legal Basis for Data Processing

We process personal data based on the following legal grounds:

- Compliance with legal obligations (Article 6(1)(c) GDPR)
- Legitimate interest (Article 6(1)(f) GDPR)

6. Data Retention

We retain personal data only for as long as necessary to fulfill the purposes outlined in this policy or as required by law.

7. Data Sharing and Third-Party Services

We do not sell or share your personal data with third parties, except:

- When required by law or authorities
- With trusted third-party service providers such as our web hosting provider (Wix.com) for operational purposes
- When necessary to fulfill contractual obligations

8. Data Subject Rights

Under GDPR, you have the following rights:

- Right to access: You can request access to your personal data.
- Right to rectification: You can request corrections to inaccurate or incomplete data.
- Right to erasure: You can request deletion of your data (subject to legal exceptions).
- Right to restrict processing: You can request limited processing of your data.
- Right to data portability: You can receive a copy of your data in a structured format.
- Right to object: You can object to data processing under certain conditions.
